Program Overview and Objectives:

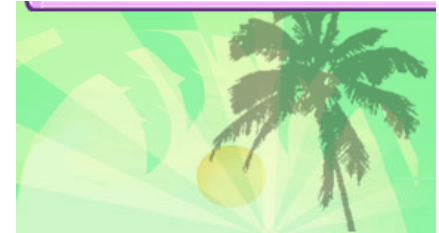
